- WQCD GRANT Town received \$232,000.00 for the wastewater plant project. Next step will be taking out a loan then proceeding with installation. The dateline is January 2025 to finalize the wastewater plant.
- RECYCLING CARDBOARD has been furnished for free for one year, will now cost \$30.00 per month. We have chosen to pay every 6 months.
- HIGHLINE CANAL LEASE Kenny Mills paid \$5,800.00 for the year 2024/2025. Requested an extension of lease possibly up to 5 years. TRUSTEE CHAVEZ MOVED, TRUSTEE HOLLAND seconded a motion to approve for one year, 2025/2026. Motion carried.
